LIMITED LIFETIME WARRANTY

Five Years – Standard textiles (not to exceed the original manufacturer's warranty), finishes, tacking surface of tackboards, writing surface of whiteboards

Five Years – Electric height adjustable bases

One Year - Electronic components

Not Covered – Customer's own materials

Exclusions:

This limited warranty does not apply and no other warranty applies to:

- Normal wear and tear, which are to be expected over the course of ownership.
- Damage caused by abuse, misuse, neglect, vandalism, accident, disaster, improper storage, chemical damage, water or fire.
